## **1. PURPOSE**

Appointment of a specialist Service Provider to Draft, Review and Amend Process Maps and SOPs for the Credit Risk, Post investments; Compliance; and Legal sections in KZN Growth Fund Trust.

## **2. BACKGROUND**

KZN Growth Fund Trust (KGFT) is a fund, established and capitalized by the Provincial Government to provide debt and equity. The main objective of the KGFT is to provide support for creating an enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad-Based Black Economic Empowerment (B-BBEE).

### **2.1 Procurement Philosophy**

It is the policy of KGFT, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development, and support of businesses from disadvantaged communities (small, medium, micro-enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion, and support for the moral values that underpin the above, in terms of KGFT Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KGFT.

The KGFT wishes to engage with service providers who are equally committed to maintaining high-quality services and better pricing.

### **3. SCOPE OF SERVICES REQUIRED WORK AND DELIVERABLES**

#### **3.1 Scope of Service**

The purpose of this Request for Proposals (RFP) is to invite proposals for the review of KwaZulu-Natal (KZN) Growth Fund Trust Standard Operating Procedures (SOP). The successful Service Provider will Review current SOP's and Amend Process Maps and propose SOP's for the Credit Risk, Post Investment, Compliance and Legal section at KZN Growth Fund Trust. The Service Provider must also do the below;

- I. Analyse and identify missing critical steps in the current and new processes and procedures
- II. Update and draft new SOPs and processes;
- III. Implementation of Project Management to embed changes and new SOP's through - Review, Test, edit and repeat.
- IV. Conduct workshops - output to the user team and entity.

Expected Output – including all documentation

- a. Four Final SOP documents and flow charts for:
  - Credit,
  - Legal;
  - Post investment monitoring and
  - Compliance
- b. Updated Process Maps for
  - Credit,
  - Post investment monitoring and

### **4. EVALUATION OF QUOTATIONS**

Selection will be conducted over three stages:

Stage 1 – Compliance with minimum requirements

Stage 2 – Functionality Requirements

Stage 3 – Price & B-BBEE Evaluation

## 5.1 Compliance with minimum requirements

All quotations must be accompanied by the following documents:

- 5.1.3 Tax Compliance Status Certificate
- 5.1.4 Valid BEE Certificate
- 5.1.5 Provide three written letters of reference for similar work performed. Letters must not be older than 3 (three) years

**Failure to submit any of the above documents will disqualify the bidder from further evaluation**

## 5.2 Functionality Requirements

- 5.2.1 An assessment of Functionality will be based on the evaluation criteria noted in the table below. Each of the evaluation criteria in the table will carry a weighting as indicated, and the service provider will be required to score a minimum of 70 points (out of the 100 points).

5.3.2 Fixed price quotations are required; price must be inclusive of VAT and all costs relating to disbursements and accommodation.



- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
