1. PURPOSE

The Kwazulu-Natal Growth Fund Trust (KGFT) invites quotations from suitably qualified service providers to provide KGFT with 2 x Temporary resources (Deal Execution).

2. BACKGROUND

KZN Growth Fund Trust (KGFT) is a Trust, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KGFT is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KGFT, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KGFT Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KGFT.

The KGFT wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED

Kwazulu-Natal Growth Fund Trust (KGFT) is looking for highly experienced and suitably qualified resources to assist with deal execution on a temporary basis.

KZN Growth Fund is a developmental finance institution based in Durban, providing both Debt and equity funding solutions to privately owned companies in KZN.

The resources will be responsible for sourcing and screening investment opportunities, executing and closing transactions. The role requires an individual that is driven by their commitment to contribute to economic development, broad-based black economic empowerment and improving the lives of people in KwaZulu Natal by executing innovative, developmental, and profitable investments for the KZN Growth Fund.

3.1 Key performance areas:

- Solicit appropriate investment opportunities and conduct initial screening of projects in terms of the KGFT's investment policies;
- Undertake and present full appraisals of debt and equity transactions to the Fund's various decision-making Committees;
- Ensure deal closure by taking responsibility for optimal financial, institutional and legal structuring;
- Coordinate with the risk, legal and ESG team for the conclusion of transaction agreements;
- Provide innovative and flexible financial structures for complex transactions;
- Identify opportunities to initiate viable projects, project origination through the facilitation of project preparation, and business plans with the intention of closing investment deals;
- Perform valuations of investee companies;
- Identifying the exit opportunity and timing, and assisting in the exit from equity portfolio investments;
- Support the Investment Principals, Chief Investment Officer and Chief Executive Officer in drafting and presentation of reports, evaluations, plans, etc. related to the business of the KZN Growth Fund;
- Undertake research and provide recommendations on significant developments, emerging opportunities and challenges in the priority sectors.

3.2 The following minimum requirements must be met to be considered for this position:

- An Honours Degree in Finance/Banking/Economics/Engineering and related fields;
- A post-graduate qualification such as CA, CFA or MBA would be a strong advantage;

- At least 8 years' experience in corporate finance, project finance or private equity with a proven track record in project origination, desk top assessment, deal negotiation and legal contracting in a financial institution;
- Proven experience in Financial Modelling, Financial Analysis, Due Diligence Investigations, financial structuring, valuation and risk identification and mitigation;
- Understanding of project and commercial agreements such as off take agreements, EPCM contracts, operations and maintenance agreements, shareholder agreements, inter-creditor and facility agreements;
- Genuine commitment to highest ethical standards and to sustainable development with particular sensitivity to social and environmental issues;
- Negotiation, analytical, interpersonal and management skills;
- Diplomatic and business orientated manner;
- Computer literacy (MS Office Suite);
- Ability to communicate at all levels, both internally and externally and
- Excellent written and verbal communication in English.

4. CONTRACT DURATION

The contract period is for four (4) months.

5. AWARD OF THE RFP

KGFT is not obliged to accept and award this tender to the lowest bidder or any other bidder.

6. EVALUATION PROCESS AND CRITERIA

Selection will be conducted over three stages as detailed below:

Stage 2 – Functionality Requirements

Stage 3 – Price and Specific Goals

6.1 STAGE 1 – COMPLIANCE WITH MINIMUM REQUIREMENTS

6.1 All proposals must be completed and accompanied by:

6.1.1 Company Profile

6.1.2 Evidence of registration on the National Treasury Central Supplier Database (or proof of registration)

6.1.3 Tax Compliance Status Pin

6.1.4 CV for the candidate: -CVs must meet the prescribed requirements; - CVs must be prepared in an easily understandable format (as per Annexure A) along with a summary that motivates the applicant, potential value add, applicant availability, salary required, EE status and interview availability;

6.1.5 Proof of qualifications for the candidate: Certified copies of all relevant qualifications for this role;

All bids duly lodged as specified in this RFQ will be examined to determine compliance with the minimum requirements and conditions. Failure to submit minimum requirements documents will disqualify the service provider from proceeding to the next evaluation stage.

6.2 FUNCTIONALITY EVALUATION

Scores will be tabulated to 100 points. Respondents must score 70 points and over to be assessed on their financial offer and preference score.

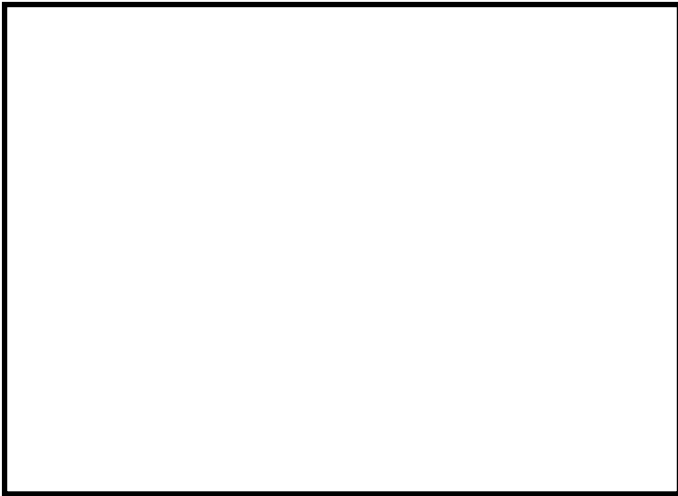

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 - \frac{Pt - P_{min}}{P_{min}} \right) \text{ or } Ps = 90 \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 + \frac{Pt - P_{max}}{P_{max}} \right) \text{ or } Ps = 90 \left(1 + \frac{Pt - P_{max}}{P_{max}} \right)$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

(a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

Table 1: Specific goals for the tender and points claimed are indicated per the table below.

(Note to organs of state: Where either the 90/10 or 80/20 preference point system is applicable, corresponding points must also be indicated as such.

 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person’s conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
