1. PURPOSE

The KwaZulu-Natal Growth Fund Agency (KZNGFA) invites quotations from suitably qualified service providers to provide pastel accounting maintenance and support for 12 months.

2. BACKGROUND

Kwazulu-Natal Growth Fund Agency (KZNGFA) is an Agency, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KZNGFA is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

2.1 Procurement Philosophy

It is the policy of KZNGFA, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KZNGFA Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KZNGFA.

The KZNGFA wishes to engage with service providers who are equally committed to maintain high quality services and better pricing.

3. SCOPE OF SERVICES REQUIRED

KZNGFA invites quotations from suitably qualified service providers with pastel accounting experience to assist KZNGFA with Ad-Hoc Support and Maintenance on Sage Pastel Partner Version 19.3.5 and Sage Evolution as per the specifications below.

The appointed service provider will be expected to render professional support services including, but not limited to, the following:

3.1. Sage Evolution & Sage Pastel Support

- User account administration and password resets.
- Configuration and setup of Sage Evolution for new users, including Fixed Assets module access.
- Assistance with financial year-end procedures and entity type changeovers.
- Resolution of supplier account balancing issues in both current and prior financial periods.
- Assistance with system user settings, access rights and configuration within Sage Pastel.
- Support with updating and maintaining Sage Evolution databases.
- Troubleshooting system errors, performance issues and general operational queries.

3.2. Fixed Assets & Depreciation Management

- Amend depreciation methods and rates, including changing values from 33.33% to 20%, or as instructed.
- Support with fixed asset register configuration and related module issues.

3.3. SQL Server & Database Administration

- Password resets and access support on SQL Server environments.
- Installation and configuration of new SQL Server instances.
- Migration, relocation, backup, restore and recovery of Sage databases
- Routine database health checks and maintenance support.

3.4. Service Delivery

- Services will be rendered strictly on an ad-hoc basis, as and when requested by KZNGFA.
- No guaranteed minimum workload or fixed monthly volume of work is implied.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

4.6. I, the undersigned, who is duly authorised to do so on behalf of the company/firm, certify that the points claimed, based on the specific goals as advised in the tender, qualifies the company/firm for the preference(s) shown and I acknowledge that:

- i) The information furnished is true and correct;
- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;
- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
